Subject: Extension of the Period of Accreditation status granted to Management Programs of Xavier Labour Relations Institute (XLRI), C H Area (East), Jamshedpur – 831001, Jharkhand from 5 years to 6 years.

Sir,

This has reference to NBA's letter of even number dated 07.12.2015 under which Management programs offered by your Institution were granted accreditation for 5 years by National Board of Accreditation.

2. National Board of Accreditation has decided that in all cases where Management program(s) of an Institution were granted accreditation for a period of 5 years, the period of accreditation of these program(s) shall be extended from 5 to 6 years subject to the condition that they meet the Pre-qualifiers for extension of duration of accreditation from 5 to 6 years. The Pre-visit qualifiers submitted by **Xavier Labour Relations Institute (XLRI), C H Area (East), Jamshedpur – 831001, Jharkhand** in respect of the Management programs have been considered. The programs are meeting all the parameters of pre-visit qualifiers for accreditation of 6 years. Accordingly, the competent authority in NBA has approved the following accreditation status to the programs as given in the Table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Xavier Labour Relations Institute (XLRI), C H Area (East), Jamshedpur – 831001, Jharkhand** as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

7. The accreditation status awarded to the programs as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
